## How Can You Afford to Apply with Several Agencies or Adoption Attorneys?

The Adoption Consultant has negotiated low upfront fees (in some cases no upfront fees) for clients to register with agencies and attorneys to be shown to potential birthmother situations. Thus, you are not limited to going with only one agency or attorney.

Established relationships of your Adoption Consultant with key personnel at agencies and attorneys offices enable you to succeed faster than if you were on your own.



## Why Use An Adoption Consultant?

Adopting a child can be one of the most rewarding experiences of your life.

However, for adoption beginners, the adoption process can seem overwhelmingly complicated, time consuming, and frustrating – especially if you are eager to get started.

We are not attorneys, so there are times when an Adoption Consultant will recommend that you seek legal counsel during your adoption process. Through an Adoption Consultant you have access to nationwide agencies and attorneys in states where birthparents' consent cannot be revoked. (Usually 12 to 72 hours after birth before signing, then irrevocable).
